CRITICAL RACE THEORY: Its Meaning And Implications For Education

PRESENTER: Dr. Jacqueline Goffe-McNish




Critical race theory (CRT), is an academic and legal concept that is more than 40 years old. CRT is based on the idea that race is a social construct, and that racism is not merely the product of individual bias or prejudice, but also something embedded in legal systems and policies.

Dr. Goffe-McNish will facilitate an active discussion of the elements of this theory and its implications for education. Five elements addressed by CRT are: the centrality of race, racism, intersectionality; the challenge of the dominant ideology; a commitment to social justice; the centrality of experiential knowledge; and a transdisciplinary perspective.

This is also connected to education by addressing education inequities and the need to actively engage in a process to set equity and equality focuses for learning.

Dr. Jacqueline Goffe-McNish was a professor of English and Humanities at Dutchess Community College for thirty-two years. She has taught Composition, Introduction to Literature, African American Literature, Caribbean Literature, Technical Writing, and Bible as Literature. She received her Doctorate in Education from St. John Fisher University. Dr. Goffe-McNish is an active member and past president of Poughkeepsie AAUW, where she was Chair of the Diversity Committee for five years.

Arnie's career in science began in 1964 as a Biology/Pre Med student at Hunter College in New York City, which became a coeducational institution that year. Attending college with excellent women scientists and educators, Arnie became interested in the history and role of women in science, especially as the understanding of the structure and function of DNA was becoming the foundation of the Biological Sciences.



Arnie's education and career progressed from Doctoral studies in Neurophysiology, to Science Education, to teaching in, and administering, science education programs in school districts and colleges for more than forty years.

Arnie has served science education beyond the classroom as a consultant to the New York State Education Department and as President of the Science Teachers Association of New York State. He currently serves as an active member of the STANYS Conference and Legislative Committees. In 2012 Arnie was elected a Fellow of STANYS and in 2023 selected as a member of the Hunter College Alumni Association Hall of Fame.

PRESIDENT'S MESSAGE

Happy New Year! 2025 will be a unique year for our branch – our 100th Anniversary year! But more about that from the Centennial Committee as the year progresses. On behalf of our Board of Directors we hope that 2025 will be a healthy and joyful year for you.

On a more serious note, I want to inform you of an issue that arose right before the Thanksgiving holiday and that the Board dealt with at our December meeting. It involves our two scholarship offerings through the Foundation at Dutchess Community College (DCC). I was informed by Diana Pollard, the Executive CEO for the foundation, that a challenge had been brought against the language in our scholarship description as well as that of a few other scholarships. Our description reads as follows:

"As part of its goal to advance the continuing education of women, the Poughkeepsie branch of AAUW awards these scholarships to full-time graduating female students (or graduating female students who were enrolled in 12 or more credits last semester AND are currently enrolled in 6 or more credits) in any discipline who are continuing their education at a four-year institution. Preference is given to post-traditional female students."

According to Diana, the challenge stated that the word *female* is discriminatory. When I explained that our mission statement is "Advancing equity for women and girls through education, advocacy, and research," she agreed that this challenge seemed to violate our intent, but their lawyers were not confident our rationale would hold up in court. Below is the statement of the lawyers:

"The answer is that there is a disconnect between the ability of individuals to discriminate based on gender (and in other ways) in their charitable giving under state law, on the one hand, and the inability of institutions such as the College to discriminate based on gender, on the other hand. This inability precludes the College from holding and administering gender-restricted scholarship funds, whether directly or through a related foundation, even though a donor can lawfully make the restricted gift in the first instance.

This has been an evolving area of the law for the past couple of decades which is likely to become increasingly hot in the near term. Reading the political tea leaves, it appears that restrictions currently being imposed on colleges with regard to remedial or restorative discrimination will spread to the entire nonprofit sector."

Diana and the attorneys suggested the following changes to our wording:

"As part of its goal to advance the continuing education of women, the Poughkeepsie branch of AAUW awards these scholarships to full-time graduating students (or graduating students who were enrolled in 12 or more credits last semester AND are currently enrolled in 6 or more credits) in any discipline who are continuing their education at a four-year institution. Preference is given to post-traditional students who are committed to the continuing education of women."

The issue and the suggested changes to our scholarship description were brought to the Board on December 5, 2024, discussed and voted on. The vote was unanimous to change the language to the suggested one. This change involves only our two already established scholarships. Our Matching Fund challenge will continue with the desired result to establish another scholarship and provide money to increase the amounts in our current scholarships. The language of the new scholarship will be determined at another time.

This whole matter came as a shock to me, but as the lawyer states, it is one that has been evolving over time. Our mission does not change, and I have advised the Board to be vigilant in watching and learning about legislation and policies that could affect that mission. I ask you, our members, to also be vigilant and let any Board member know if you hear or read of something that could negatively affect our mission. We do not promote political candidates, nor do we take sides in a political campaign, but we advocate for policies that promote our mission. And we will be watchful for policies that could negatively affect our mission.

Currently Out of the Office

Beginning January 1, 2025, New York will become the first state in the nation to offer **paid time off** for **prenatal care** or

any medical care related to pregnancy. Under this new policy, any privately-employed pregnant New Yorker will be able to receive an additional 20 hours of paid sick leave for prenatal care in addition to their existing sick leave. This ensures they can receive the care they need without putting their employment at risk. Federal, state, or local government employees are not covered by New York State's Paid Prenatal Leave Law. Private Sector



employees are defined to exclude federal, state and local government employees but include persons, corporations, limited liability companies or associations employing an individual in any occupation, industry, trade, business, charter school, private school and not-for-profit.

This is a new legal requirement that provides a **separate benefit** from other leave policies and laws. Employees are entitled to 20 hours of paid prenatal leave **in addition to** any other available maternity/sick/leave options. All private-sector employees are covered regardless of number of employees or size of business. Paid Prenatal Leave may only be used by the employee directly receiving prenatal health care services.

Paid Prenatal Leave covers health care services received by an employee during their pregnancy or related to such pregnancy, including physical examinations, medical procedures, monitoring and testing, and discussions with a health care provider related to the pregnancy.

This law applies to fertility treatment or care appointments including in-vitro fertilization and end-of-pregnancy care appointments.. This paid prenatal leave program in New York State does not cover abortion; it is specifically designed to be used for healthcare services related to pregnancy, such as prenatal appointments, but excludes abortion procedures. However, it appears that it would apply to after care for loss of an embryo or fetus.

Employers cannot ask employees to disclose confidential information about their health condition(s) as a condition of requesting to use Paid Prenatal Leave or to disclose confidential information about their health condition(s). An employee has the option to use NYS Sick Leave, Paid Prenatal Leave, or an existing employer leave policy to attend prenatal

health care appointments. However, an employer **cannot** require an employee to use one leave type over another. Paid Prenatal Leave is an **additional** tool available.

Postpartum leave under the New York State Paid Family Leave provides eligible employees with up to 12 weeks of job protected, paid time off to bond with a new child, care for a family member with a serious health condition, or to assist loved ones when a family member is deployed abroad on active military service. This time can be taken all at once, or in increments of full days. Benefits are improved for 2025.
